Curie Release Letter #1

Dear Ms. Heard:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDCC #2-0415-00 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDCC"), I have received your request to dispose of irradiated hardware in the following shipments:

- The 1st shipment is scheduled to be shipped on or about August 1, 2024, with a disposal volume 55.7 cubic feet with approximately 10,600 curies of activity.
- The 2nd shipment is scheduled to be shipped on or about August 12, 2024, with a disposal volume 55.7 cubic feet with approximately 9,820 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during the State of Texas Fiscal Year to accommodate the shipment of an additional 20,420 curies and 111.4 cubic feet as requested in your letter dated July 17, 2024. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 20,420 curies and 111.4 cubic feet of irradiated hardware requested in the shipments.

Therefore, you are authorized as of the date of your receipt of this communication to import from Southern Nuclear Operating Company E I Hatch Plant to the Compact Facility in Andrews County, Texas 20,420 curies and 111.4 cubic feet of irradiated hardware described in agreement TLLRWDCC #2-0415-00. This shipment is approximately 62% of the volume and 68% of the activity specified in Article II.J. of agreement TLLRWDCC #2-0415-00. With this letter, Southern Operating Company E I Hatch Plant has remaining 178.6 of 290 cubic feet and 20,420 of 30,000 curies authorized to be shipped conditionally under agreement TLLRWDCC #2-0415-00.

Please update the TLLRWDCC as you send shipments and schedule for future shipments so we may update our tracking of imports under your agreement.
