## RE: Import Agreement TLLRWDCC #2-0191-01 Curie Release Letter #3

Dear Mr. Long:

Pursuant to the condition expressed as a part of Article II.J. (c) of your Import Agreement TLLRWDCC #2-0191-01 with the Texas Low-Level Radioactive Waste Disposal Compact Commission ("TLLRWDCC"), I have received your request to dispose of irradiated hardware in the following three shipments:

- On or about November 26, 2018, a shipment containing 56.25 cubic feet of waste with approximately 11,100 curies of activity.
- On or about December 4, 2018, a shipment containing 56.25 cubic feet of waste with approximately 8,870 curies of activity.
- On or about December 13, 2018, a shipment containing 56.25 cubic feet of waste with approximately 7,330 curies of activity.

As of the date of this letter, there is sufficient capacity for importation during State of Texas Fiscal Year 2018 to accommodate the shipment of 27,300 curies and 168.75 cubic feet as requested in your letter dated November 5, 2018. This letter does not authorize the importation to the Compact Facility in Andrews County of any cubic feet or curies of low-level radioactive waste beyond the 27,300 curies and 168.75 cubic feet of irradiated hardware requested.

Therefore, you are authorized as of the date of your receipt of this communication to import from Entergy Grand Gulf Nuclear Station to the Compact Facility in Andrews County, Texas 27,300 curies and 168.75 cubic feet of irradiated hardware described in agreement TLLRWDCC #2-0191-01. This shipment is approximately 21% of the volume and 23% of the activity specified in Article II.J. of agreement TLLRWDCC #2-0191-01. With this letter, Entergy Grand Gulf Nuclear Station has remaining 290 of

740 cubic feet and 44,300 of 130,000 curies authorized to be shipped conditionally under agreement TLLRWDCC #2-0191-01.
